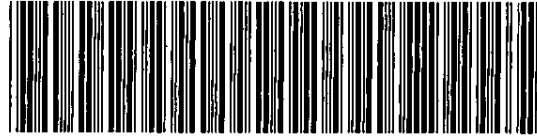

ARTICLES OF INCORPORATION

FIRST: That the name of said corporation shall be Titusville Sunrise Kiwanis Incorporated.

SECOND: The principal office of the corporation for the transaction of business is to be located within the County of Brevard, State of Florida.

THIRD: The Corporation shall have perpetual existence.
