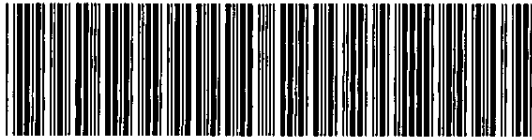

ARTICLES OF INCORPORATION
OF
CORNERSTONE CHRISTIAN CHURCH, INC.

A Corporation Not for Profit

ARTICLE I

The name of this corporation shall be Cornerstone Christian Church, Inc., and the initial principal address of the corporation is 4004 Highway 4, Santa Rosa County, Jay, Florida 32565.

ARTICLE II

The period of duration of this corporation is perpetual. Corporate existence shall commence upon the filing of these documents with the Secretary of State.

ARTICLE III

The purposes for which this corporation is organized are as follows:

- (A) (1) To own, erect, maintain and manage a parsonage and church buildings, including classrooms and educational buildings in or near the community of Jay in Santa Rosa County, Jay, Florida, and to furnish and supply the same as may be necessary.
- (2) To provide for receiving monies in the form of tithes and offerings which shall be used for the maintenance of said buildings, payment for the same, paying salaries of the employed personnel of said corporation, and further, a portion of such funds may also be used at the discretion of the corporation to promote benevolent and missionary causes throughout the earth.
- (3) To take, hold, receive and enjoy all property and money that may be given, bequeathed, devised, conveyed or transferred to or settled upon the said corporation, and to hold, use, invest and enjoy the same, and/or the profits, rents and income therefrom for the enumerated purposes of the said corporation.

- (4) To have power to negotiate loans, borrow money, give mortgages on property held by the corporation to secure payment thereof, and to transact any other necessary business.
- (B) (1) To promote fellowship, cooperation, protection, recognition and propagation of the Gospel of Jesus Christ of Nazareth at home and abroad and for the support of public worship.
- (2) To ordain Ministers and Christian workers to any and all orders as may be deemed expedient or necessary.
- (3) To send out home and foreign missionaries.
- (4) To establish churches, auxiliaries, clubs, schools, and societies of a Christian nature in accordance to GODS Holy Word.
- (5) To print, publish and distribute and sell books, magazines, tapes and other Literature in any way connected with the purpose of this organization.
- (6) To do any and all things reasonably necessary to carry out the above and foregoing purposes.

ARTICLE IV

The members of this corporation shall be all the members of the Cornerstone Christian Church, Inc. in Jay, Florida. The qualification and acceptance of members into the said church and/or corporation shall be fixed in the constitution and by-laws of said corporation.

ARTICLE V

The street address and city of the initial registered office of the corporation is 4806 Jack Floyd Road, Jay, Florida 32565, and the name of the registered agent is R. C. (Shorty) Floyd, 4806 Jack Floyd Road, Jay, Florida, 32565.

ARTICLE VI

The number of the Trustees constituting the initial Board of Trustees is [three], and the names and addresses of the persons who are serving as the initial Trustees are:

The Board of Trustees shall at all times be subject to the direction and control of the members of the corporation. On the death, retirement, resignation, expulsion, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in church, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE VII

This corporation is organized under a non stock basis.

ARTICLE VIII

The administrative officers of this corporation shall be a President, a Vice-President, a Secretary, a Treasurer, who shall be the same person who is the Treasurer of the Church and the Board of Deacons. There shall be such other officers as the "Church" may from time to time direct and elect. Officers shall be elected annually pursuant to the by-laws of this corporation. The minutes of the corporation may be the same as the minutes of the Board of Trustees and of the Church, insofar as same may pertain to the temporal or business matters of the Church.

ARTICLE IX

The names of the members of this corporation who are to manage all the affairs of this corporation until the next election of members of the Board of Trustees shall be:

ARTICLE X

The members of this corporation shall adopt such by-laws and amendments thereto as shall be in accordance with the instructions and approval of the members of the corporation, for the carrying on of the business for which this charter is granted, not inconsistent with the laws of the State of Florida, but only after vote of the members. The said by-laws are to be consistent and in accord with the Constitution and By-Laws of Cornerstone Christian Church, Inc. insofar as possible.
