

Articles of Incorporation
In Compliance with Chapter 617, F.S., (Not for Profit)

Article I

The name of the Corporation shall be: KMCOOKIE FIGHT For Pancreatic Cancer Research Inc.

Article II

The principal place of business and mailing address of this Corporation shall be:

Article III

KMCOOKIE FIGHT For Pancreatic Cancer Research Inc. is a PUBLIC BENEFIT nonprofit corporation that is organized and operated exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, including, for such purposes, the making of distributions to organizations that qualify as tax-exempt organizations under Section 501(c)(3) of the Internal Revenue Code. Specifically, this nonprofit corporation is organized and operated to provide relief to poor, distressed, and underprivileged patients diagnosed with pancreatic cancer, by raising funds necessary to fuel and support pancreatic cancer research, that could ultimately help identify the prevention, diagnosis, and treatment of pancreatic cancer, and to increase public awareness of pancreatic cancer and the importance of screening for the early detection of pancreatic cancer, and to encourage the public to assist with funding new projects and programs that strive to improve care for pancreatic cancer patients and provide an effective treatment and cure for pancreatic cancer.

Article IV

The manner in which the directors are elected or appointed: During the annual meeting, the officers shall elect the directors of the Corporation.

Purpose of Obtaining 501(c)(3) Tax-Exempt Status: No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.

Dissolution: Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated

exclusively for charitable, educational, or scientific purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
