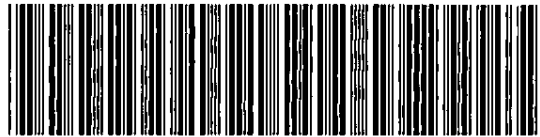

ARTICLE I NAME/REGISTERED OFFICE

The name of this corporation shall be: Let Us Stand United Together, Inc.
The corporation's registered office is located at: 810 Lake Shore Dr. #20 Lake Park, Florida 33403

ARTICLE II PURPOSE

This corporation is organized exclusively for educational purposes and community within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes the making of distributions to organizations that also qualify as section 501 (c) (3) exempt organizations. To this end, the corporation Let Us Stand Together United, Inc. will serve the people in Lake Park. Our program will provide ongoing opportunities for parents and children to ensure the success of our community. We at Let Us Stand United Together believe that through a partnership with both Lake Park Elementary and the town of Lake Park, we can make a tremendous difference in the students and parents well being.

Let Us Stand United Together will provide a quality after school program that supports the physical, emotional, social and cognitive development of children. We will assist with homework in a secure environment during out of school hours. Additionally, Let Us Stand United Together is committed to meeting the needs of all families within the community who require after school child care. Let Us Stand United Together will help our families better acclimate to the changing needs of our times. Let Us Stand United Together will be a catalyst for change in the community of Lake Park by empowering families by improving their quality of life.

Let Us Stand United Together will strive to provide a safe environment where all children may academically progress and play. All funds whether income, principal, acquired gift or contribution shall be devoted to the purpose of our goals.

ARTICLE III LIMITATION

At all the times the following shall operate as conditions restricting the operation and activities shall be used to remunerate the corporation:

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any to Director or officer of corporation nor to any other private person, except solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;
2. No substantial part of the activities of the corporation shall constitute the carrying propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by

publication or distribution of statements), any political campaigns on behalf of, or in opposition to, any candidate for public office;

3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
4. The corporation shall not lend any of its assets to any officer or director of this corporation, or guarantee to any person the payment of a loan by an officer or director of this corporation.

ARTICLE IV Directors/Members

Let Us Stand United Together Inc. shall have non-voting members. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No Director shall have any right, title or interest in or to any property of the corporation. The Board of Directors of Let Us Stand United Together will be comprised of the following natural persons:

ARTICLE V Debt Obligations and Personal Liability

No member, officer, or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.


ARTICLE VI DISSOLUTION

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes




