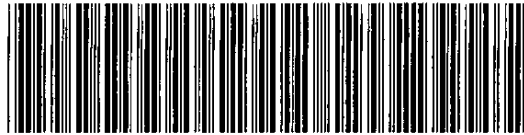

### **Article I Name**
