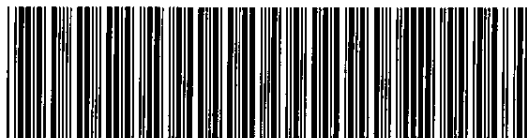

**Article IX Net Earnings**
