 which not less than 21 days notice(stating the terms of the resolution to be proposed)
 shall be given. Upon the dissolution or winding up of Cameroonians of Tampa Bay, Inc
 its assets remaining after payments, or provision for payment, of all debts and liabilities
 of this corporation shall be distributed to a nonprofit fund, foundation or corporation which
 is organized and operated exclusively for charitable purposes and which has established
 its tax exemp status under section 501(c)3 of the Internal Revenue Code
