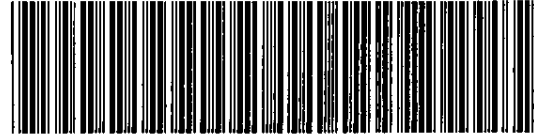

ARTICLE I

NAME

The name of this corporation is CAMEROONIANS OF TAMPA BAY, INC.

ARTICLE II

ARTICLE III

The purpose for which this corporation is organized is:

To promote the social, cultural values, developmental and educational aspects of Cameroonians in the greater Tampa bay area: we strive to bring our support to the needy, relief of the poor and the distressed born in Cameroon and the United States of America through our charitable activities.

- Cameroonians of Tampa Bay is organized exclusively for educational and charitable purposes within the meaning of section 501(c)(3) of the internal revenue code.
- Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue code of 1986 (or the corresponding provision of any future Unites States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

ARTICLE IV

The manner in which directors are elected or appointed is by secret ballot, with a One-year renewable term of office.






