



No part of the net earnings of this corporation shall inure to the benefits of or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on 1) by a corporation except from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code or 2) a corporation to which contributions are deductible under Section 170 (c) (2) of the Internal Revenue Code
