The undersigned, acting as the incorporator of a not-for Profit Corporation under the Florida Not for Profit Corporation Act, as set forth in Chapter 617.0202 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation

#### ARTICLE I: NAME

The name of the Corporation shall be Torchbearers Foundation Inc, hereinafter referred to as the "Corporation"

#### ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

This corporation shall have perpetual existence unless dissolved according to law.

#### ARTICLE IV: PURPOSE

This corporation is organized completely for charitable and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code. The purposes and operations of this Corporation shall be specially restricted and limited as follows:

 No part of the net earnings, properties, or assets on dissolution or otherwise, shall inure to the benefit of any private person or individual, or any member, director or officer, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article VI.

- 2. No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation. The Corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office.
- 3. The corporation shall not operate for the purpose of carrying on a trade or business for profit, or engage in any prohibited transaction described in Section 503 of the Internal Revenue Code or the corresponding provision of any subsequent Internal Revenue Code or tax law

#### ARTICLE VI: MEMBERSHIP

This corporation shall not have any members.

#### ARTICLE VII: REGISTED OFFICE AND AGENT

The Corporation's registered office shall be located at 8601 NW 34<sup>th</sup> Place Unit 101A, Sunrise FL 33351 and Shakira Clemetson is the registered agent of the Corporation at that address

#### ARTICLE VIII: BOARD OF DIRECTORS
