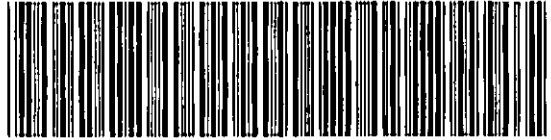



Amendment No. 1: Article 13, Articles of Incorporation

**ARTICLE 13
AMENDMENTS**

Amendments to these Articles shall be proposed and adopted in the following manner:

(Article 13.1 Remains Unchanged)

13.2 Adoption. Amendments ~~shall~~ may be proposed either by a majority of the Board of Directors of the Association or by not less than one-third (1/3) of the Unit Owners, and A proposed amendment may be adopted in the manner provided in Chapter 617, Florida Statutes and in the Act (the latter to control over the former to the extent provided for in the Act) by the affirmative vote of at least a majority of the entire voting interests.
