ARTICLES OF INCORPORATION

VANDERBILT LAKES COMMONS ASSOCIATION, INC.

The undersigned, for purposes of forming a corporation under the Florida Not For Profit Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS
