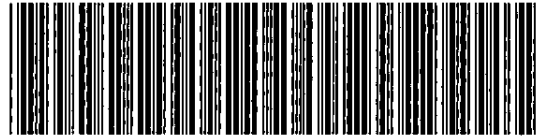

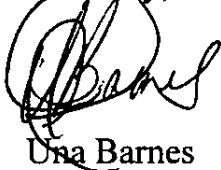

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

El Kedesh Deliverance Temple, Inc.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The general purposes for which the corporation is organized are:
1. Charitable and educational within the meaning of section 501 (c) (3) and 509 (a) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
2. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) and 509 (a) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
3. To preach the gospel of Jesus Christ.
4. To serve as a House of Worship for Christian believers in Jesus Christ.
5. To serve the community through outreach programs, cultural events programs, and other social services in the areas of Education, Community Crime Watch, Food Distribution, and Elderly Services.
6. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise and property of any sort or nature without limitation as to amount or value, and to hold, invest, manage, use, employ, expend, disburse, dispose of such property and the income, principal and proceeds of such property for any of the purposes set forth herein.
7. To do other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The management of the Corporation shall be vested in a Board of Directors. The number constituting the initial Board of Directors shall be three. The number of directors may be increased or decreased from time in accordance with the Bylaws, but shall never be less than three. The Board of Directors shall be appointed annually. The Bylaws may provide for ex-official and honorary directors, and their rights and privileges.

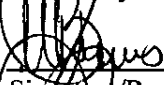
