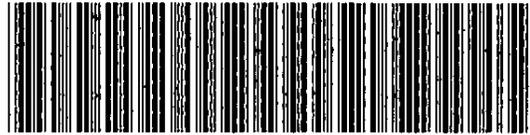

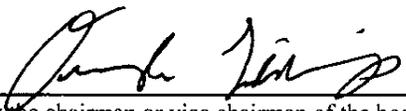

**ARTICLES OF INCORPORATION**  
**In Compliance with Chapter 617, F.S. (Not for Profit)**

**ARTICLE I NAME**

The name of the corporation shall be:  
Learning In Fine-arts Expression, Education and Experience, Inc.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
2600 SW 85<sup>th</sup> Terrace, Miramar, Florida 33025

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

This corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, including but not limited to such purposes, as the making of distributions to organizations that also qualify for Section 501(c)(3) exempt status. The purpose of this corporation is:

- To provide vocational outreach, practical experience and exposure to creative/media arts.
- Serve as a link between professionals in the media industry and individuals.
- To develop multimedia productions that educate and inform
- Foster community support and appreciation for the creative arts.

**ARTICLE IV LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**ARTICLE V DISSOLUTION**

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**ARTICLE VI INITIAL DIRECTORS AND/OR OFFICERS**

The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, as defined by the corporation's bylaws. The number of directors constituting the initial board of directors is 4; their names and addresses are as follows:

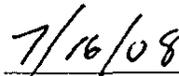

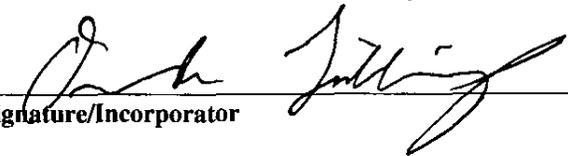

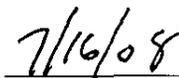
