

AMENDMENT TO ARTICLES OF INCORPORATION OF POMPANO BEACH CLUB RECREATION CENTER, INC.

(additions indicated by underlining, deletions by "----" and unaffected language by ". . . ")

ARTICLE III Powers

The powers of the Association shall include, and shall be limited by, the following provisions:

* * *

- 2. The Association shall have all of the powers and duties set forth in the Florida Not-For-Profit Corporation Act as well as those bestowed upon the Association pursuant to the Florida Condominium Act, except as limited by these Articles and the Association's By-Laws, and all of the powers and duties reasonably necessary to operate the Facility as set forth in said By-Laws, including but not limited to the following:
- (a) To make and collect assessments against members of the Association to defray the costs, expenses and losses of the Facility, provided that a meeting between the Board of Governors and the Boards of Directors for Pompano Beach Club Association, Inc. and Pompano Beach Club North Association, Inc. is held at least fourteen (14) days prior to the Board of Governors' meeting at which the proposed assessment will be discussed and voted upon, and the proposed assessment (or some compromise assessment) is approved by majority vote of the Board of Directors for each Condominium Association, failing which the assessment may not be adopted by the Board of Governors or imposed against the Members.
