SECRETARY OF STATE

We, the undersigned residents of the State of Florida, being 21 years or more of age, do hereby associate ourselves together for the purpose of forming a **non-profit** corporation under the statutes of the State of Florida.

### ARTICLE ONE NAME AND LOCATION

The name of the corporation shall be **Rejoice and Hope Christian Church, Inc.** and its location shall be 3245 NE 184<sup>th</sup> Street # 13303, Aventura, County of Miami-Dade, State of Florida.

#### ARTICLE TWO DURATION

The period of duration of this non-profit corporation shall be indefinite.

### ARTICLE THREE PURPOSE CLAUSE

The purpose of the corporation shall be to provide a Center for the study and Practice of religion and all other lawful acts within meaning of section 501 ( C )(3) of the Internal Revenue Code. Said corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501 ( C )(3) of the Internal Revenue Code or corresponding section of any future Federal Tax Code.

### ARTICLE FOUR NON-STOCK CORPORATION

The corporation shall be non-stock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE FIVE DIRECTORS

The number of Directors constituting the Initial Board of Directors of the Corporation is two and the names and addresses of the person who are to serve as initial Directors are as follows:

#### ARTICLE SIX **ELECTION OF DIRECTORS**

The manner in which the directors are to be elected by the members is as follows: commencing on March 1, 2008, the election of the directors shall be by a majority of votes of the members of the corporation.

#### ARTICLE SEVEN CORPORATE OFFICERS AND THEIR FUNCTIONS

The general officers of the corporation shall be president, vice-president, secretary and treasurer.

The principal duties of the president shall be to preside at all meetings of the members and the Board of Directors and to have general supervision of the affairs of the corporation.

The Board of Directors may provide for the appointment of such additional officers as may deem for the best interest of the corporation.

Whenever the Board of Directors may so order, any two offices, the duties of which do not conflict, may be held by one person.

The officers shall perform such additional or different duties as shall from time to time be imposed or required by the Board of Directors, or as may be prescribed from time to time by the Bylaws.
