The undersigned incorporator hereby makes and files these Articles of Incorporation for the purpose of forming a corporation not for profit under the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of this corporation is The Town Center at East Lake Woodlands C.C. Condominium Association, Inc., a non-profit Florida corporation.
