. ARTICLES OF INCORPORATION

In Compliance with Chapter 617, Florida Statutes (Not for Profit) and IRS Code 501(c)(6)

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Not-for-Profit Corporation under the Not-for-Profit Corporation Law of the State of Florida, do hereby certify:

ARTICLE ! - NAME

The name of the Corporation shall be NAHREP FLAGLER COUNTY, INC.

ARTICLE II -- PRINCIPAL OFFICE

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(6) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
