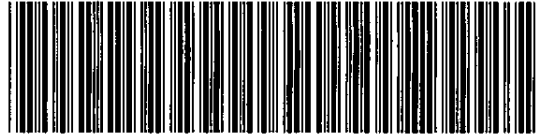

ARTICLE I

Name

The name of this corporation shall be the Prime Time Club, Inc.

ARTICLE II

Place of Business and Address

The principal office of the Prime Time Club, Inc. ("Prime Time") in the State of Florida shall be located in the City of Tampa, County of Hillsborough, Florida. The mail address shall be: 3815 N Nebraska Ave; PO Box 7492; Tampa FL 33673-7492. Prime Time may have such other offices, either within or without the State of Florida, as the Board of Directors may designate or as the business of the corporation may require from time to time.

ARTICLE III

Purpose

Section 1. Prime Time's purpose is to promote the education and benefits of savings, investments, and retirement planning.

Section 2. This corporation shall observe and adhere to all local, state and federal laws pertaining to non-profit organization as defined in section 501(c)(1) or the Internal Revenue Service Code and Chapter 617, of the Florida Statutes.

ARTICLE IV

Director Election

Section 1. Whenever a vacancy exists on the Board of Directors, whether by death, resignation, or otherwise, the vacancy shall be filled by a majority vote of the members at a regular or special meeting of the general membership. Any person elected to fill the vacancy of a director shall have

the same qualifications as were required of the director whose office was vacated, as provided by the Bylaws.

Section 2. Any director may be removed, with or without cause, by the vote of two-thirds of the directors or general membership at any regular meeting or special meeting called for that purpose. At any such meeting, any vacancy caused by the removal may be filled.

Section 3. Any person elected to fill a vacancy in the Board of Directors shall hold office for the unexpired term of his/her predecessor in office, subject to the power of removal contained herein.

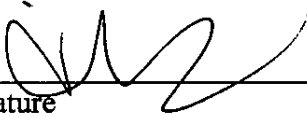

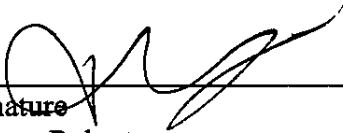
