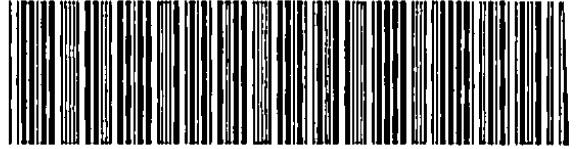

as of October 15th, 2022. A check in the amount of \$35.00 is enclosed.


The corporation is being closed due to retirement.
