## ARTICLES OF CORRECTION TO THE ARTICLES OF INCORPORATION OF FOUNDATION FOR QUALITY CHILD CARE, INC.

Pursuant to the provisions of Section 617.0124, Florida Statutes, this not-for-profit corporation hereby files these Articles of Correction within 30 days of the file date of the document being corrected.
