

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME - The name of the Corporation shall be:

First Advent Christian Church of Live Oak, Inc.

<u>ARTICLE II PRINCIPAL OFFICE</u> - The principal place of business and mailing address of this Corporation shall be:

699 Pinewood Drive SW, Live Oak, Suwannee County, Florida 32064

ARTICLE III PURPOSE - The purposes for which the Corporation is organized are:

The purpose of this Corporation shall be to maintain the public worship of God according to the example and teaching of the Bible; and all other lawful purposes; and

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code; and

Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

<u>ARTICLE IV MANNER OF ELECTION</u> - The manner in which the directors are elected or appointed:

Directors shall be elected by the members of the First Advent Christian Church of Live Oak, Inc., each January at the Annual Meeting of the Corporation.
