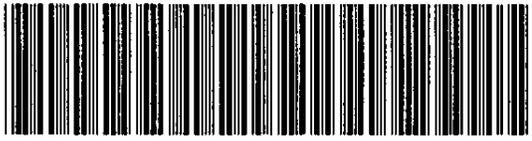

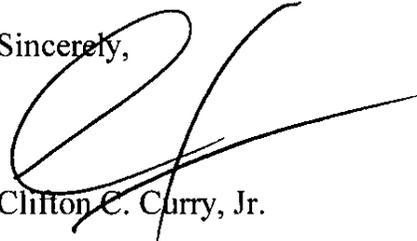

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation. The amendments were adopted by the members and the number of votes cast for the amendments were sufficient for approval. The date of the adoption of the amendments was September 15, 2008 and are effective immediately.

**ARTICLE III.** The purpose for which the corporation is organized is: The organization is organized exclusively for charitable, religious educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code;

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purposes.

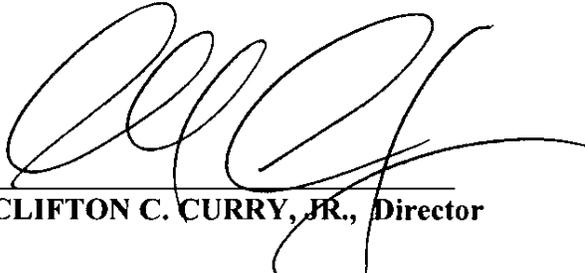
