ARTICLES OF INCORPORATION OF GO FOR THE GLOW FOUNDATION, INC.

08 MAR -3 AMII: 23

ARTICLE I - NAME

The name of this not-for-profit corporation shall be GO FOR THE GLOW FOUNDATION, INC.

ARTICLE II - DURATION

The duration of this not-for-profit corporation is perpetual.

ARTICLE III - PURPOSES AND OBJECTIVES

The purposes and objectives of this not-for-profit corporation shall be for staging holiday light shows and conducting fundraising to put on such annual shows, including conducting garage sales to finance these expensive shows. The general nature of business to be conducted by this corporation shall be to do all things that now are or may hereafter be allowed to corporations not-for-profit by the laws of Florida even though the existing laws may hereafter be repealed.

ARTICLE IV - POWERS

This not-for-profit corporation shall possess and be authorized to exercise all of the powers authorized by the Florida Statutes and all other lawful powers necessary to accomplish the purposes and objectives of the corporation.

ARTICLE V - MEMBERSHIP

Any individual or organization who subscribes to the purposes of this not-for-profit corporation as set forth in Article III may be admitted to membership in the not-for-profit corporation in accordance with the procedures and provisions established in the By-Laws of the corporation. The Board of Directors of this corporation shall have the full authority to decide conditions for membership and to make provisions in the By-Laws setting forth these conditions.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office, and the name of the initial registered agent at such address, shall be:

REBECCA P. F. SMITH 723 E. Pierson Dr. Lynn Haven, FL 23444 who is familiar with and accepts the duties and responsibilities as registered agent for said corporation. The initial principal office of the corporation is 723 E. Pierson Dr., Lynn Haven, FL 23444 and the initial corporate mailing address shall be 723 E. Pierson Dr., Lynn Haven, FL 23444, until such other principal office and corporate mailing address is established by the majority vote of the Board of Directors. The principal office and corporate mailing address shall be set forth in the corporation By-Laws and may be changed from time to time in accordance with the procedure for amending said By-Laws.

ARTICLE VII - MANAGEMENT AND INITIAL BOARD

The management, conduct and control of the affairs, property and business of this not-for-profit corporation shall be vested in a Board of Directors, which shall not be less than one in number, as determined by the Board of Directors. The method of election of directors shall be set forth in the By-Laws.

ARTICLE VIII - BY-LAWS

The By-Laws of the corporation shall be made, altered, amended, or rescinded by a majority of the Board of Directors present in person only at a regular or special meeting.
