The undersigned, being not less than 100% of all of the bona fide mobile home Park (21) owners of Floridian Gardens a.k.a. Pink Top Mobile Home Park, (21 home owners, 2 park rentals, 3 abandoned, 17 vacant lots equals 44 total lots) for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation: (Exhibit "A")

ARTICLE I. NAME

The name of the corporation is "WE WILL NOT BE FORGOTTEN ASSOCIATION, INC."

ARTICLE II.

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of the corporation is Lot #6, 14915 Old U.S. Highway 441, Tavares, FL 32778 and the mailing address is: P. O. Box 37, Tavares, FL 32778.

ARTICLE III. **PURPOSES**

The Corporation is organized and shall be operated exclusively as a non-stock organization for the following purposes:

- (a) To establish an association of homeowners of mobile homes located at Floridian Gardens a.k.a. Pink Top Mobile Home Park, in Lake County, Florida;
- (b) In order to exercise the rights provided in Florida Statutes 723.071 including, but not limited to, exercising its right to negotiate for, acquire and operate the Mobile home park of Floridian Gardens a.k.a. Pink Top Mobile Home Park on behalf of the mobile home owners;
- (c) In order to exercise its right to convert the mobile home park to a condominium, a cooperative form of ownership, or other type of ownership Pursuant to Florida law:
- (d) To exercise and engage in any other powers or business of mobile home park associations as permitted by Florida law;
- (e) To engage in any lawful activities which are in furtherance of the purposes of the Corporation as described herein; and
- (f) To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including, without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for

any of the purposes set forth herein, and to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE IV. MANNER OF ELECTION

The manner in which the directors are appointed or elected is a follows: The incorporator will select the initial board of Directors. Directors that are to be replaced will be first appointed by a majority vote of present seated Directors and then approved at the annual meeting by a simple majority of the home owners in such manner as prescribed in the Bylaws.

ARTICLE V.

NAMES AND ADDRESSES OF INITIAL DIRECTORS

The management of the Corporation shall be vested in a Board of Directors. The number of Directors constituting the initial Board of Directors is five (5). The number of Directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than three (3). The Members of the Corporation shall approve the appointment of all future Directors as provided in the bylaws. The initial Directors are:

ARTICLE VIII. DURATION AND TIME AND DATE OF COMMENCEMENT

The duration of the Corporation is perpetual, and the Corporation shall commence at the time and date of filing of these Articles with the Secretary of State.

ARTICLE IX. OFFICERS

The Officers of the Corporation shall consist of a President, Vice-President, Secretary, Treasurer, and such other Officers and Assistant Officers as may be provided in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed in the Bylaws. ARTICLE X. MEMBERS

The Corporation shall have Members who shall have all rights and privileges of voting members of the Corporation. The qualification for members and manner of their admission shall be as stated in the bylaws. The names of the initial Members are as listed on Exhibit "A".

ARTICLE XI. BYLAWS

The bylaws of the Corporation are to be made and adopted by the Board of Directors, and may be altered, amended or rescinded by the Board of Directors then presented to the members of the corporation for approval as prescribed in the Bylaws. The bylaws shall conform with provisions of Florida Statutes 723.078, and other applicable laws.

ARTICLE XII. AMENDMENT

The Members of the Corporation reserve the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Directors and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended from time to time, unless more specific provision for amendments are adopted by the Corporation pursuant to law.

ARTICLE XIII. INDEMNIFICATION

The Corporation shall indemnify each Officer and Director, including the former Page 3 of 8

Officers and Directors, to the fullest extent permitted by the laws of the State of Florida.

ARTICLE XIV. NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefits of the Members, Directors or Officers, except to the extent permissible under law.

ARTICLE XV. LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III (Purposes) hereof.

ARTICLE XIV. NONSTOCK BASIS

This Corporation is organized on a nonstock basis. This Corporation shall not issue shares of stock.

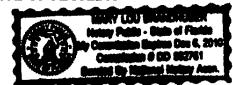
