ARTICLES OF INCORPORATION

VOCUFRON, INC.

In compliance with Chapter 617, Florida Statutes, a majority of whom are citizens of the Florid States, desiring to form a Non-Profit Corporation, do horeby certify:

ARTICLE I

NAME

The name of the corporation shall be VOCUFRON, Inc.

ARTICLE II

PRINCIPAL OFFICE

The place in this state where the principal office of the corporation is to be located at 12040 NW 22⁵⁶ Court, is the City of Miami, Florida 33167.

ARTICLE III

PURPOSE

The primary purposes corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future

federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph: Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
