

Article VIII – Compliance

Life Quest General Baptist Church must be in compliance with the *Rules For Organization* of the General Association Of General Baptists.

Article IX – Dissolution

If Life Quest General Baptist Church Inc. is dissolved, any existing church property, both real, personal and intangible shall in no way be diverted to other purposes, but *title* to any real property shall pass to the General Baptist Council of Associations for the use of the National Missions department of General Association of General Baptists, and trustees holding personal or intangible property for the dissolved church shall sell or dispose of the same only on the order and under the direction of the National Missions Director. The proceeds from the sale thereof will be proportionately divided between the local Missions Board and National Missions in a way that is commensurate with support given by each entity.
