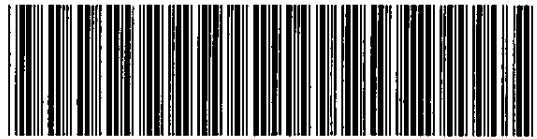

ARTICLES OF INCORPORATION

FOR

RUN WITH THE VISION DELIVERANCE OUTREACH MINISTRIES INC.

ARTICLE ONE

The name for the corporation is Run with the Vision Deliverance Outreach Ministries Inc.

ARTICLE TWO

The principal place of business and the mailing address of this corporation shall be 1003 Franklin Street, Jacksonville, Florida 32206.

ARTICLE THREE

The general purpose for which this corporation if formed are to interpret and expound the Holy Bible: to maintain it as the foundation of all *spiritual truth*: to establish a church; to ordain ministers of the Gospel, authorized by it to teach and minister unto its members, perform marriages, administer Sacraments and burial of the dead, and to exercise such authority over its membership through suitable regulations and bylaws as may be appropriate for the establishment and maintenance of a sect of the Christian faith and for such religious purposes as will qualify it as exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1985, as amended, or corresponding provisions of any subsequent federal tax laws, including for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code, as may be amended from time to time. This corporation shall not, as a substantial part of it's activities, carry on propaganda or otherwise attempt influence legislation: nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE FOUR

The manner of which the directors are elected or appointed: each director will be appointed by the pastor the corporation shall have a membership distinct from board of directors. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof, shall be set forth in by-laws.


