**ARTICLES OF INCORPORATION OF
CHRISTIAN MINISTRIES OF PINELLAS, INC.**

Pursuant to the provision of Chapter 617, Florida Statutes, The Florida Not For Profit Corporation Act, the undersigned corporation adopts the following articles of articles of incorporation.

ARTICLE I - NAME

The name of the corporation is CHRISTIAN MINISTRIES OF PINELLAS, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principle office of the corporation is 8799 Bardmoor Blvd., #102, Largo, FL 33777.

ARTICLE III - PURPOSES

The corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law), including, but not limited to, for such purposes, promoting and/or assisting in promoting, the Gospel of the Lord Jesus Christ; promoting and/or assisting in promoting, the building of the Kingdom of the Lord Jesus Christ; rendering spiritual assistance and guidance to born-again believers in the Lord Jesus Christ and the general public through activities such as counseling, education, and various media; educating and training believers in the Lord Jesus Christ regarding Christian living and ministry; supporting Christian missionary activities in the United States and any foreign country; assisting the needy; assisting other Christian organizations in the carrying out of their religious, charitable, and educational purposes; and any other lawful purpose or purposes not for pecuniary profit and not specifically prohibited to Not For Profit Corporations under other laws of the State of Florida.

ARTICLE IV - MANNER OF ELECTION OF TRUSTEES

The directors of the corporation shall be referred to as "Trustees." The corporation shall have a minimum of three (3) Trustees. The method of election of Trustees shall be as stated in the Bylaws of the corporation.

ARTICLE V - INITIAL TRUSTEES

The names and addresses of the initial Trustees of the corporation are: Sharon L. Lukosavich, 6286 99th Cir. N., Pinellas Park, FL 33782; Billie S. Mills, 7501 Ulmerton Rd., #1912, Largo, FL 33771; and Rev. Keith A. Schweikert, 8799 Bardmoor Blvd., #102, Largo, FL 33777.

ARTICLE VI - INITIAL REGISTERED AGENT AND STREET ADDRESS

The name of the initial registered agent of the corporation at the registered office is Rev. Keith A. Schweikert. The street address of the registered office of the corporation is 8799 Bardmoor Blvd., #102, Largo, FL 33777.

ARTICLE VII - INCORPORATORS

The names and addresses of the incorporators are: Sharon L. Lukosavich, 6286 99th Cir. N., Pinellas Park, FL 33782; and Rev. Keith A. Schweikert, 8799 Bardmoor Blvd., #102, Largo, FL 33777.

ARTICLE VIII - PRIVATE INUREMENT

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or on behalf of the corporation and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE IX - POLITICAL INVOLVEMENT

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE X - RACIAL NONDISCRIMINATION

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against applicants, students, employees, and others on the basis of race, color, or national or ethnic origin.

ARTICLE XI - MEMBERSHIP

The corporation shall not have members.

ARTICLE XII - LIMITATION OF CORPORATE POWERS

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue law).

ARTICLE XIII - BYLAWS

The corporation shall have Bylaws that include a Statement of Faith. The method of amending or altering the Bylaws shall be as stated in the Bylaws of the corporation.

ARTICLE XIV - AMENDMENTS TO ARTICLES OF INCORPORATION

The method of amending and/or restating these Articles of Incorporation shall be as stated in the Bylaws of the corporation.

ARTICLE XV - DISSOLUTION

The corporation may only be dissolved by a two-thirds (2/3) majority vote of the members of the Board of Trustees. The vote must be by written ballot signed by the Trustee voting. In the event that the corporation is dissolved, the Trustees shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation to such organization or organizations organized and operated exclusively for religious, charitable, or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue law), as the Trustees shall determine. Any assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes.

ARTICLE XVI - DURATION OF CORPORATION

The duration of the corporation shall be perpetual unless dissolved according to the laws of the State of Florida.

ARTICLE XVII - EFFECTIVE DATE OF CORPORATION

The effective date of the corporation is March 4, 2008.

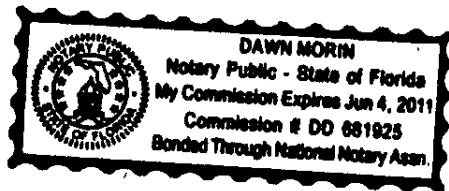
