ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Jacob James Casey Scholarship and Educational Fund, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 4245 SW 20th Avenue, Ocala, Florida 34471.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: This is a non-profit corporation organized solely for general educational, religious and charitable purposes pursuant to the Florida Corporations Not for Profit Law set forth in Section 617 of the Florida Statutes, including, for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any Future Federal tax code.

ARTICLE IV DURATION

The term of existence of the corporation is perpetual.

ARTICLE V AUTHORIZED ISTOCK SHARES) [MEMBERSHIP CERTIFICATES]

A. This corporation shall not be authorized to issue shares of stock and/or membership certificates and shall not have any members.

ARTICLE VI MANNER OF ELECTION

The initial Board of Directors shall consist of eight (8) directors as listed in Article VII, all of which have been elected by the Incorporator. Replacement and/or additional directors shall be elected by the then current Board of Directors.

ARTICLE VII DIRECTORS AND/OR OFFICERS

The corporation shall have a minium of three (3) directors, a maximum of eight (8) directors and the initial officers and directors of the corporation shall be the following:

ARTICLE VIII MANAGEMENT OF CORPORATE AFFAIRS

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted solely by the Board of Directors.

ARTICLE IX EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE X TRANSFER OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes withing the meaning of section 501(c)(3) of the Internal Revenue Code, or the

corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
