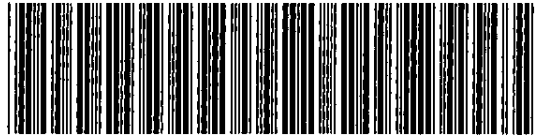



ARTICLES OF INCORPORATION
FOR
REACHING OUT MINISTRIES INTERNATIONAL

I

The name of this corporation is REACHING OUT MINISTRIES INTERNATIONAL, INC. The corporation's principal street address is: 1071 North Gaucho Circle, Deltona, FL 32725.

II

- A. This corporation is a religious corporation and is not organized for the private Gain of any person. It is organized primarily for religious purposes under the Nonprofit Religious corporation Laws.
- A. The specific purpose of this corporation is to communicate the teaching of Jesus Christ and to support Christian ministries. This will entail the direction of mission trips to aid international ministries and social works. There will also be an itinerary of speaking engagements and activities to local and distant churches, Christian schools, and clubs, etc.

III

The name and address in this state of the corporation's initial agent for service of process is:

- A. The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this organization shall ever inure to the benefit of a director, officer, or member of the corporation, or to the benefit of any private individual.

- B Upon the closing and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund; foundation or corporation organized and operated exclusively for charitable and/or religious purposes and that has established its tax-exempt status under Internal Revenue code 501 (c)(3)

IV

- A. This corporation is organized exclusively for religious purposes within the meaning of Internal Revenue Code Section 501 (c)(3). Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code or (ii) by a corporation, contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code.
- A. No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for political office.

V

The Board of Directors shall be elected annually by the vote of a majority of the Regular members of the corporation. Each Director shall serve for a term of three (3) years. A Director may succeed himself. Each Director, including a Director elected to fill a vacancy, shall hold office until the expiration of the term for which elected and until a successor has been elected.

The Board of Directors shall consist of between one (1) and six (6) Directors.
