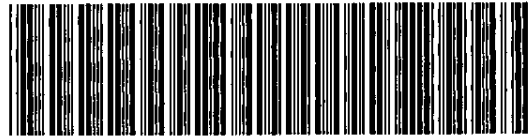



AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
ROCKHILL MISSIONARY BAPTIST CHURCH, INC.

In accordance with Section 617.1007, Florida Statutes, the Articles of Incorporation of the above-named corporation are amended and restated in their entirety and the corporation adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I: NAME

The name of this corporation is Rockhill Missionary Baptist Church, Inc.

ARTICLE II: PRINCIPAL

The principal office of this corporation shall be located at 3036 Weston Street, Oviedo, Florida 32765.

ARTICLE III: PURPOSE

The primary purpose for which this corporation is formed is to cultivate, promote, publish, announce, and proclaim the name of our Lord Jesus Christ utilizing all available lawful means. To this end, the corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or as it may be subsequently amended, including the making of distributions to or for the use of exempt organizations under the Internal Revenue Code at the time.

ARTICLE IV: EXISTENCE

The existence of this corporation shall be perpetual.

ARTICLE V: LIMITATIONS ON CORPORATE ACTIVITY AND ASSETS

A. Political Activity. The corporation shall not participate or intervene in political elections, or attempt to influence legislation.

B. Corporate Assets. Upon dissolution of the corporation, the remaining assets of the corporation shall be used exclusively for exempt purposes in accordance with Section 501(c)(3) of the Internal Revenue Code.

ARTICLE V: DIRECTORS

The number of Directors for the corporation shall be established within the Bylaws of the corporation. Additionally, the powers, terms, and means of election of Directors shall be established in the Bylaws of the corporation.

ARTICLE VI: MEMBERSHIP

The qualifications, powers, duties, rights, and privileges shall be established by the Bylaws of the corporation.

Pursuant to the Corporation's current Articles of Incorporation, Bylaws, and Section 617.1007, Florida Statutes, this Amended and Restated Articles of Incorporation does not require member approval, and accordingly, was adopted by the Board of Directors on January 17, 2012.
