# ARTICLES OF Amudmut FOR ERCEGI, Inc.: A NONPROFIT CORPORATION

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of Florida, do hereby certify:

#### **ARTICLE I - NAME**

The name of the Corporation shall be ERCEGI, Inc. Doing Business As ERCEGI.

#### ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The place in this state where the principal office of the Corporation is to be located is the City of Jacksonville, Duval County.

#### **ARTICLE III - PURPOSE**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Through informal education programs, grassroots evaluation of needs, community asset building, research and adaptation of best practices, and development and incubation of solutions, ERCEGI will fulfill its mission of engaging citizens in well-designed strategies to improve their neighborhoods, schools, and economies.

#### ARTICLE IV - ELECTION/APPOINTMENT OF DIRECTORS

The board directors will be recruited from the founding community at large by the initial founders to represent a broad spectrum of specialization and ensure fulfillment of the programmatic functions. Future board openings will be filled per the bylaws drafted by the initial board.

#### **ARTICLE V - DIRECTORS/OFFICERS**

The names and addresses of the persons who are the directors/officers of the Corporation are as follows:

#### ARTICLE VI - PRIVATE INUREMENT DOCTRINE

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these

articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE VII - DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
