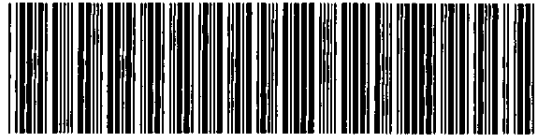

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE


