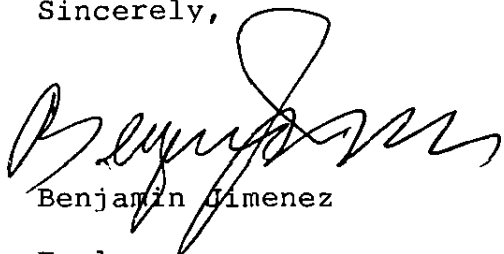

ARTICLES OF INCORPORATION
FOR
ORGANIZACION LATINO AMERICANA DE ASISTENCIA SOCIAL INC.
(A NOT FOR PROFIT CORPORATION)

The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: Organizacion Latino Americana de Asistencia Social Incorporada

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

1. To help latin inmigrants in adapting to the social and laboral life in the United States of America.
2. Offer christian sociology and physicology counselling to persons depressed and others involved in the use of prohibited practices (drugs, alcohol and other vices)
3. Counsel women, children (boys and girls) and adolecents abused or victims of domestic violence.
4. Provide help to any latin country suffering from disasters or other acts of God.
5. Consolidate the family structure by means of christian counselling, the principal filosophy of OLAS (Organizacion Latino Americana De Asistencia Social).
6. Assist with available resources homes for the elderly regarding the use of christian orientation as a mean to obtain peace and spiritual tranquility.

ARTICLE IV - CHARITY PURPOSES

The corporation shall be formed, maintained, and operated for charity purposes as provided in section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future Internal Revenue Code. Also, all assets of the corporation shall be dedicated to the purposes described in these Articles of Incorporation.

ARTICLE IV - BOARD OF DIRECTORS (BOARD OF TRUSTEES)

Section 1. Be it enacted that Apolinar Luciano and Fatima Guzman are directors of the Organizacion Latino Americana De Asistencia Social Incorporada, and their successors as such, be and they are hereby created the body of politic and corporate, by the name and style of the Trustees of the Organizacion Latino Americana De Asistencia Social Indcorporada and by that name shall have the perpetual succession and a common seal, and may sue or be sued, plead or be pleaded in any court of law or equity in this state.

Section 2. That when any vacancy in said Board may occur by death, resignation, or otherwise, or other disqualification to act, to be judged of by the trustees at a regular business meeting, it shall be competent for the member of such entity to fill such vacancy or vacancies at any regular business meeting. Said entity shall, also, have power to remove from office any one or more of said trustees, a majority of all the members present at a regular business meeting concurred therein, and may proceed to fill such vacancy in the manner provided appointment of a trustee shall take place until notice of such intention has been given at a previous regular business meeting of the entity. The manner of election of the Directors shall be as provided in the by-laws of the corporation.

Section 3. That the above named trustees, and their successors, are hereby invested with full power, to be selected by the entity to purchase and receive title of any property, and any property of the Organizacion Latino Americana De Asistencia Social Incorporada may be used exclusively and in the benefit of the entity (should there ever be a schism) as adhere, to the articles of as now held by the entity, forever.

Section 4. That said trustees, or their successors, shall have and they are hereby vested with power to sell and convey any title they may hold, or may hereafter hold, in trust for said entity, or may make such other disposition of the same as said church may order. Notice have been given at a previous meeting of such intended sale or disposition, and not otherwise; and to do and perform all acts common to limited corporations not to conflict with the laws of this state.

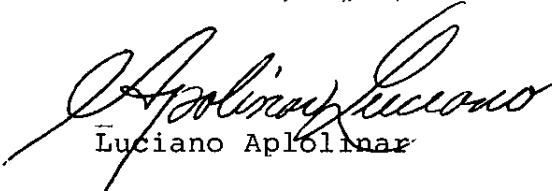

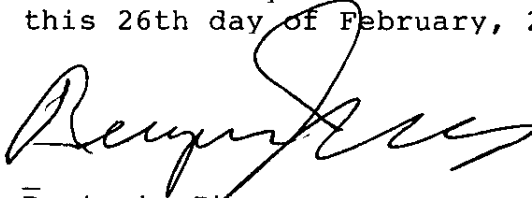

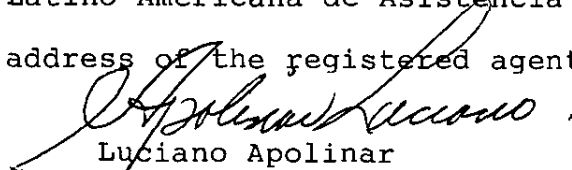
