**ARTICLES OF INCORPORATION FOR  
FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC.**

By these Articles of Incorporation (the "Articles"), the undersigned Incorporator forms a corporation "Not For Profit" in accordance with Chapter 617, Florida Statutes, and pursuant to the following provisions:

**ARTICLE I—NAME**

The name of the corporation shall be FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC.

**ARTICLE II—DURATION**

The corporation shall exist perpetually unless and until dissolved according to law. Corporate existence shall commence upon the filing of these Articles with the Florida Department of State.

**ARTICLE III—DEFINITIONS**

The following words shall have the definitions set forth below for the purposes of the Articles:

"Articles" shall mean these Articles of Incorporation.

"Board" or "Board of Elders" shall mean the Board of Elders of the Corporation.

"Bylaws" shall mean the Constitution and Bylaws of the Corporation.

**ARTICLE IV—PRINCIPAL**

**OFFICE**

The principal office of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall be located at 500 N. Bumby Ave., Orlando, Florida 32803.

**ARTICLE V —REGISTERED AGENT**

Matt West, chairman of the deacons, whose address is 415 Lochmond Dr, Fern Park, FL 32730, is hereby appointed the initial registered agent of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC.

**ARTICLE VI—PURPOSE OF THE CORPORATION**

Powers. Notwithstanding any other provisions of these Articles, this organization shall not discriminate on the basis of race, familial status, sex or disability as interpreted under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

#### ARTICLE VII—BOARD OF ELDERS

The affairs of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall be managed by a Board of Elders, consisting of Elders, whose number may be increased, decreased, added to, or subtracted from at any time as prescribed in the Bylaws of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. The names and addresses of persons who are to act in the capacity of Elder until appointment or election of their successors pursuant to the Bylaws are as follows:

#### ARTICLE VIII—VOTING RIGHTS AND RULES OF ORDER

Each Elder shall be entitled to one vote, except as provided for in these Articles or the Bylaws. Except as provided for in these Articles or the Bylaws, all business meetings of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall be governed by Robert's Rules of Order.

#### ARTICLE IX—ADMINISTRATIVE POSITIONS

The affairs of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall be administered by the elders and other officers, designated in the Bylaws. The officers shall be appointed by the Board of Elders, and they shall serve at the pleasure of the Board of Elders. In addition, the initial administrative positions of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC., and their respective addresses are as follows:

#### ARTICLE X—INDEMNIFICATION

Indemnification. Every Elder and every officer of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall be indemnified by FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him or her in connection with any proceeding whether civil, criminal, administrative or investigative, or any settlement of any proceeding, or any appeal from such proceeding to which he or she may be a party or in which he or she may become involved by reason of his or her being or having been an Elder or Officer of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC., or having served at FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC.'s request as an Elder or Officer of any other corporation, whether or not he or she is an Elder or Officer at the time such expenses are incurred, regardless of by whom the proceeding was brought, except in relation to matters as to which any such Elder or Officer shall be adjudged liable for gross negligence or willful misconduct, provided that in the event of a settlement, the indemnification shall apply only when the Board of Elders of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. approves such settlement and reimbursement as being for the best interest of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. The foregoing right of indemnification shall be in addition to, and not exclusive of, all other rights to which such Elder or Officer shall be entitled.

Expenses of Lawsuits. Expenses incurred in defending a suit or proceeding whether civil, criminal, administrative or investigative, may be paid by FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. in advance of the final disposition of such action, suit or proceeding if authorized by all of the non-interested Elders upon receipt of an undertaking by or on behalf of the Elder or Officer to repay such amount if it shall ultimately be determined that he or she is not to be indemnified by FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. as authorized by these Articles of Incorporation.

Insurance. FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall have the authority to purchase, at its expense, and maintain insurance on behalf of any person who is or was an Elder or Officer of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC., against any liability asserted against him or her and incurred by him or her in any such capacity, or arising out of his or her status as such, whether or not FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. would have the power to indemnify him or her against such liability under the provisions of these Articles.

#### ARTICLE XI—BYLAWS

The Bylaws of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall be adopted by the Board of Elders and may be altered, amended or rescinded in the manner provided by the Bylaws.

#### ARTICLE XII—AMMENDMENTS

Amendments to these Articles of Incorporation shall be made in the following manner:

Resolution. The Board of Elders shall adopt a resolution setting forth the proposed amendment and directing that it be submitted to a vote at a meeting of the Board of Elders. This meeting may be either annual or a specially called meeting.

Notice. Within 30 days of the next meeting of the Board of Elders, or in any other manner provided for in FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC.'s Bylaws for the giving of notice of meetings of the Board of Elders, written notice setting forth the proposed amendment, or a summary of the changes to be effected thereby, shall be given to each Elder, and each such Elder shall be entitled to vote thereon. If the meeting is an annual meeting, the proposed amendment or such summary may be included in the notice of such annual meeting.

Vote. At such meeting, a vote of the Elders shall be taken on the proposed amendment. The proposed amendment shall be adopted upon receiving the affirmative vote of two thirds (2/3), or more, of the Elders.

Multiple Amendments. Any number of amendments may be submitted to the Elders and voted upon by them at one meeting.

Filing. A copy of each amendment shall be filed with the Secretary of State, State of Florida.

Dissolution. In the event FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. is dissolved, the assets of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. shall be dedicated to a public body or conveyed to a nonprofit organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law, with a purpose similar to that of FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC.


#### ARTICLE XIII—NON-STOCK CORPORATION

FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC. is organized on a non-stock basis and shall not issue shares of stock evidencing membership in FAITH BAPTIST CHURCH OF CENTRAL FLORIDA, INC.
