

Articles of Incorporation Amendment Attachment For National Veterans Homeless Support, Inc.

Document Number N08000002609

Article III

- A. This Corporation is a not-for-profit corporation organized under Chapter 617 of the State of Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:
 - 1. Support Homeless and Distressed Veterans of the United States Armed Forces through the physical distribution of items that aid in their survival outdoors such as tents, sleeping bags, food, clothing, personal hygienic items, etc.
 - 2. Advise Homeless Veterans as to the benefits that they may be entitled to, of which they may not know are available, and facilitate their meeting with the proper organizations to insure their needs are properly taken care of
 - 3. Locate and monitor the various homeless veteran camps spread throughout Central Florida in order to assist the contacted veterans in the future and insure they are safe.
 - 4. Be positive role models for contacted homeless veterans so that they may be inspired to seek and ask for help when needed.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distribution to its officers or directors; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.
- D. Said organization is organized exclusively for charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- E. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article IV

This corporation shall not have any members, voting or nonvoting, and is governed solely by its elected or appointed Board of Directors as provided for in the bylaws.

Article VII
