# ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

OF

# JUPITER ISLAND POLICE OFFICERS ASSOCIATION, INC.

We, the undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract do hereby associate ourselves for the purpose of forming a Florida corporation not for profit, pursuant to Chapter 617, Florida Statutes.

# **ARTICLE I**

The name of this corporation shall be Jupiter Island Police Officers Association, Inc.

#### ARTICLE II

The general purpose for which this corporation is organized is to bring about unification and harmony within the Jupiter Island Police Department; to improve relations between the police, the citizens of the Town of Jupiter and the Governing Board of the Town and to better serve the citizens of the Town. In carrying out such purpose this corporation may exercise all of the powers given to non-profit corporations by Chapter 617, Florida Statutes.

#### ARTICLE III

This corporation is no organized for pecuniary profit, nor shall it have any power to issue certificates of stock or declare dividends and no part of its earnings shall inure to the benefit of any officer, director or member.

# ARTICLE IV

Any person employed by the Town of Jupiter Island Police Department with the rank of Captain, or below, is eligible for membership in the corporation. Inactive and/or honorary members may be admitted in accordance with the ByLaws of the corporation. Admission to and expulsion from membership shall be by a majority vote of the membership then current.

## ARTICLE V

This corporation shall have perpetual existence.

# **ARTICLE VI**

The initial post office address of the principal office of this corporation is to be 103 Bunker Hill Rd., Hobe Sound, FL 33455. The Board of Directors from time to time may designate such other post office address and place for the principal office of this corporation as it may see fit.

The business affairs of this corporation shall be managed by a Board of Directors. The number of directors of this corporation shall be managed by a Board of Directors. The number of directors of this corporation shall be as provided in the By-Laws, but hall not be less than three (3) in number nor more than seven (7); and shall be three (3) in number until otherwise fixed or changed by the By-Laws.

## ARTICLE VII

The names and post office addresses of the first Board of Directors, who, subject to the provisions of the Article of Incorporation, shall hold office for the first year of the corporation's existence, or until their successors are elected and have qualified, are as follows:

The By-Laws of the corporation shall be made, altered or amended by a majority vote of the membership of the corporation.

#### ARTICLE X

The registered agent to accept service of process within this State for this corporation is FREDERICK G. SUNDHEIM JR., whose registered office shall be located at 310 SW Ocean Blvd., Stuart, FL 34994

#### ARTICLE XI

These Articles of Incorporation shall be effective upon the filing with, and acceptance thereof, by the Secretary of State of the State of Florida.

## ARTICLE XII

Amendments to the Articles of Incorporation shall be approved by the Board of Directors proposed by them to the members and approved by a two-thirds (2/3) vote of the members voting.

#### ARTICLE XIII

In the event of dissolution, the residual assets of the organization shall be turned over to one or more organizations which are themselves exempt as organizations described Section 170 and Section 501(c) (3) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal

Revenue Code or to the federal, state or local government for exclusive public purposes.
