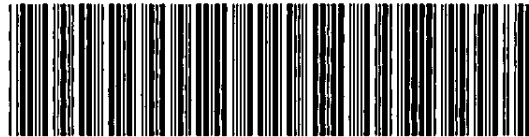

Article I Name:

Article V Registered Agent


