RESTATED ARTICLES OF INCORPORATION

OF

FIGHTING FOR CHILDREN, INC.

A FLORIDA NOT FOR PROFIT CORPORATION

DOCUMENT#: N08000002664

These Restated Articles of Incorporation were approved by a majority of the Board of Directors on May 19, 2008 pursuant to the provisions of section 617.1007, Florida Statutes.

ARTICLE I - NAME

The name of the corporation shall be: Fighting For Children, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business/mailing address shall be: 2685 Ulmerton Rd., Ste 210 Clearwater, FL 33762

ARTICLE III - PURPOSE

The Corporation is organized exclusively for charitable and educational purposes, as specified in Section 501(c)(3) of the Internal Revenue Code of 1986. In support of Foster Care organizations and adoption agencies in the U.S., Fighting For Children, Inc. seeks to provide awareness to the general public of the urgent need for adoptive homes across America for foster children of all ages, genders and ethnic groups with a primary focus on sibling groups.

- (a) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, any member, trustee, director or officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation in furtherance of those purpose set for the above), and no member, trustee, director, or officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.
- (b) No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code Section 501(h), and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

- (c) Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code; or (b) a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.
- (d) In the event of liquidation, dissolution or winding up of the Corporation, whether voluntary or involuntary or by operation of law, all of the remaining assets and property of the Corporation shall, after necessary expenses thereof, be distributed to organizations which qualify as tax-exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent federal tax laws, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- (e) Notwithstanding any other provisions of these Articles of Incorporation, neither the Corporation nor any member, trustee, director, officer, or private individual shall engage in any act of self-dealing as defined in Section 4941 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws; nor fail to distribute an amount of income required to avoid incurring tax liability under Section 4942 of the Internal Revenue Code of 1986, or corresponding provisions of the subsequent federal tax laws; nor retain any excess business holdings as defined in Section 4943 of the Internal Revenue Code of 1986, or corresponding provisions of the subsequent federal tax laws; nor make any investment in such a manner as to subject the Corporation to tax under Section 4944 of the Internal Revenue Code of 1986, or corresponding provisions of the subsequent federal tax laws; nor make any taxable expenditures as defined in Section 4945 of the Internal Revenue Code of 1986, or corresponding provisions of the subsequent federal tax laws.
- (f) No one will be denied services of the Corporation on the basis of race, color, national origin, sex, disability, family status, marital status, or religion. No one will be denied access to the services of the Corporation on the basis of race, color, national origin, sex, age, disability, family status, marital status, or religion.
