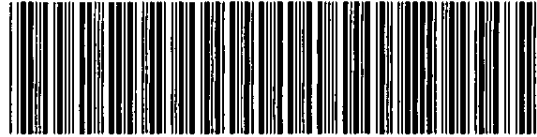

Enclosed you will find our application for a non profit corporation. Our original application was rejected because the name of Evans and Associates, Inc. was not available.


We are now requesting the name to be R P E & Associates, Inc. I checked the sunbiz.org website and this name was available.


