**THE ARTICLES OF INCORPORATION OF: COMITE POUR L'AVANCEMENT DE
PREVAL, INC.**

(Florida Not For Profit Corporation)

In Compliance with Chapter 617, F.S. (not For Profit)

The undersigned, for the purpose of forming a not for profit corporation under the laws of the State Of Florida, do hereby adopt the following articles of Incorporation:

Article I

Name

The name of the Corporation shall be: COMITE POUR L'AVANCEMENT DE PREVAL, Inc. The corporation is organized pursuant of the Florida Non profit Corporation Codes

Article II

Principal Office and Mailing Address

The principal office and mailing address of the corporation is: 115 N.W. 3eme Ave, Delray Beach, Florida 33444

Article III

Purpose

The specific purpose of this Not For Profit Corporation is for Charitable, religious, and Education training purpose in section 501(c) 3 of the Internal Revenue Code 1986, and for the purpose of engaging in any law act or activity not for pecuniary profit for which Not For Profit Corporation may be organized or permitted by the laws of the State Of Florida and the section 501(c) 3 of the Internal revenue code 1986.

It is also To Promote Democracy, Human rights, economic Development in Haiti, and basic social services like drinkable water, healthcare, and infrastructures improvement in Preval, a territorial collectivity in Artibonite, Haiti

Article IV

Membership

Any person, relative, corporation, partnership, association and/or organization who is interested in the corporation and who is capable of contributing to achievement of those purposes and the effective operation of the corporation, and who complies with requirements established from time to time by the by-laws, shall be eligible for membership, without regard to race, sex, religion, national origin and social status.

Article V

Manner of Election

The manner in which the Board of Directors is elected is set and regulated in the Corporation By-Laws

Dissolution

Upon the dissolution or Winding up of this Corporation, its assets remaining after payment or provisions for payment of all debts and liabilities of the Corporation, shall be distributed to non profit fund, foundation or corporation which is organized and operated exclusively for charitable purpose and which has established its tax exempt status under section 501 (c) 3 of the Internal revenue code 1986, as amended, or corresponding provisions of nay subsequent Federal Tax Laws.

Article IX

Limitations

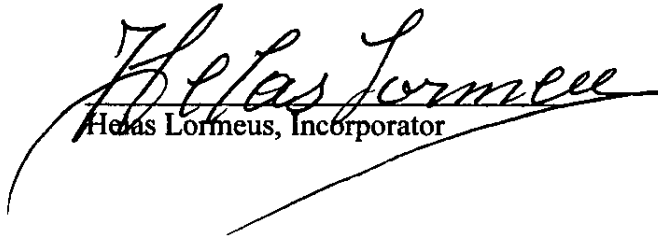
No part of the net earning of the Corporation shall insure to the benefit of or be distributed to its Directors, Officers, Members and/or other Private person, Except that the Corporation shall be authorized and empowered to reasonable compensation for services rendered and to make payments and distribution in furtherance of its purposes. The corporation shall be always in compliance with the section 501 (c) 3 and the section 170 (c) 2 of the Internal Revenue code 1986, as amended or the corresponding provision of any future United States internal revenue Law.

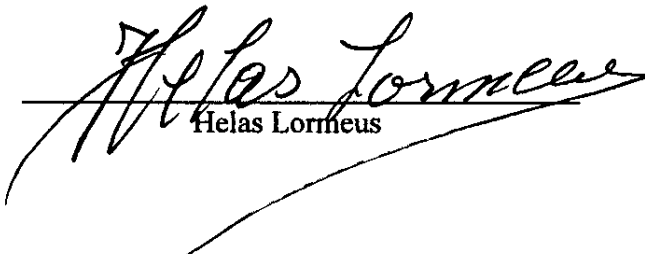
