ARTICLES OF INCORPORATION

Article of Incorporation of the undersigned, a majority of whom are citizens of the United

The Profit Corporation under the Non-Profit Corporation-Law F. States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation-La of the State of Florida, do hereby certify:

First: Name. The name of the Corporation Shall be Haitian Evangelical Outreach Ministry, Inc...

Second: Principal office. The place in this state where the principal office of the Corporation is to be located is 3555 Talisman Drive, Middleburg, Florida 32068 in Clay County. The mailing address of this corporation shall be: Post Office Box 1059, Middleburg, Fl 32050

Third: Purpose. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: Initial directors and/or officers. The names and addresses of the persons who are the initial trustees of the corporation are as follows: Jean Luckner Joseph, Sr. 3555 Talisman Drive, Middleburg, Fl 32068

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal revenue Code, or the corresponding section of any future federal tax code.

Sixth: Dissolution of assets provision. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for public purpose.
