*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I - NAME**

**ARTICLE II - PRINCIPAL OFFICE**

**ARTICLE III - PURPOSE**

The general purposes for which this corporation is organized are exclusively educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code. Without limiting the generality of the foregoing, The Promised Land Academy for Christian Education, Inc. is organized to provide educational services for disadvantaged children with barriers to learning.

The corporation shall have the power to purchase, lease or otherwise acquire property, raise funds, and do those things necessary to perform these educational services in an adequate manner.

Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal Income Taxes under Section 501(c)(3) of the Internal Revenue Code or corresponding provision of any future United States Internal Revenue law.

**ARTICLE IV - MANNER OF ELECTION**

The qualification for members and the manner of their admission are set forth in the Bylaws of the Corporation. The manner in which directors shall be appointed or elected will be determined in the Bylaws.
