

**ARTICLES OF INCORPORATION FOR
PERRY GARDEN CLUB, INC.**

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is Perry Garden Club, Inc.

Article II

The principal place of business address is: 206 Forest Park Drive, Perry, Florida 32348

The mailing address of the corporation is Post Office Box 33, Perry, Florida 32348

Article III

The specific purpose for which this corporation is organized is to stimulate a knowledge of the science, art, and specialized skills of gardening among amateurs; to cultivate the knowledge of floral arts; to cooperate with others in the beautification of our community, state, and nation; to study, support and practice wise conservation measures; to fight against pollution, and to protect our ecology; to share with members and others the fruits of our studies.

The purposes for which the corporation is organized and operated are exclusively charitable, scientific, and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

Membership shall be open to all persons and the corporation will not deny membership to any person on the basis of race, color, national origin, sex, age, physical disability, or religious beliefs or affiliations.

Article IV

The manner in which directors are elected or appointed is stated in the bylaws.
