

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment to its Articles of Incorporation:

1. **AMENDMENT ADOPTED:**

Article III, Purposes, is hereby deleted in its entirety and the following is inserted in lieu and in place thereof:

ARTICLE III
Purposes

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations qualifying as an exempt organization from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code. The charitable, religious, educational, and scientific purposes include, without limitation, the following:


- A. Operating without profit so that no part of the net earnings or assets of the Corporation shall be distributed to any private individual.
- B. Creating ballet performances of professional quality and presenting them to the public.
- C. Promoting and fostering the development, teaching, creation and performance of ballet.
- D. Sponsoring and initiating activities related to the charitable purposes set forth above.

2. **The date of adoption of the amendment was:** April 30, 2008
