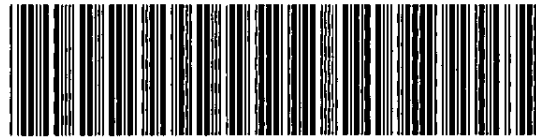

## **ARTICLES OF INCORPORATION**

### **ARTICLE I NAME**

The name of the corporation shall be: **Nimish N. Khanal Memorial Foundation, Inc**

### **ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

- (A) Provide education related grants and fellowships to promising children/young adults; in, but not limited to the Nepali and South Indian Communities, including help in establishing and developing educational institutions in Nepal
- (B) Provide means to promote and educate children and adults in health related issues, especially in the underdeveloped communities of rural Nepal
- (C) Provide supplies including but not limited to medications especially to the poor and undeveloped areas of rural Nepal.
- (D) Promote sports as a means of encouraging good health and all rounded well being.
- (E) Promote social activities both as individual and as community to encourage peace and well being of the communities.

In the performance of the stated purposes, the Foundation shall have and enjoy all rights and powers granted to a corporation organized and existing under the Florida Nonprofit Corporation Act, provided, however, the acts of the foundation shall be limited to the performance of functions related to the stated purposes and other things incidental to them or connected with them, but the foundation shall not perform any acts which cannot be performed by a corporation exempt from Federal income taxation under 501(c)(6) of the Internal Revenue Code(or the corresponding provisions of any future United States Internal Revenue Code) and shall not organize, operate or engage in any business for profit.

This Foundation shall have the power by corporate endeavor to solicit, earn or otherwise procure funds and property for corporate purposes, uses and development as permitted by these Articles, the Bylaws and the law.

**ARTICLE VIII CORPORATOR EARNINGS**

No part of the net earnings of the Foundation shall insure to the benefit of, or be distributable to its members, trustees, officers or other private persons of to the benefit of any person who has made a substantial contribution to the Foundation or to any member of the family of such donor, except that the Foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article VI hereof. Notwithstanding any other provision of these Article, the Foundation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income taxation under § 501(c)(6) if the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Code) and the applicable regulations as they now exist or as they hereafter be amended.

**ARTICLE IX DISSOLUTION**

Upon the dissolution of the Foundation, assets shall be distributed for one or more exempt purposes within the meaning of section § 501(c)(6) if the Internal Revenue Code or the corresponding section of any future Federal tax code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be distributed by a court of competent jurisdiction of the county in which the principal office of the foundation is then located exclusively for such purposes of to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
