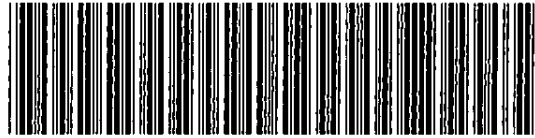

1. The name of the Corporation is "World Wide Relief Services Inc." The Corporation is organized under the Florida Not For Profit Corporation Act, Florida Statutes, Title XXXVI, Chapter 617 (2007). The period of duration of the Corporation is perpetual.
2. The principal place of business of the Corporation is 422 5<sup>th</sup> Avenue North, Jacksonville Beach, Florida 32250. The mailing address of the Corporation is P. O. Box 51153, Jacksonville Beach, Florida 32240.
3. The purposes for which the Corporation is organized and operated are exclusively charitable, religious, educational and scientific, including without limitation as authorized under state law regarding nonprofit corporations and federal law or rules regarding exempt organizations under Internal Revenue Code, as amended (IRC), section 501(c)(3):
  - a. Contribute to exempt organizations under IRC section 501(c)(3).
  - b. Provide or promote services and support to indigent people and communities throughout the world.
  - c. Provide, promote or support community, health, education, economic, religious, welfare and social improvements, including facilities, infrastructures, decent, safe and sanitary affordable housing, and services; benevolent food, clothing and material goods to indigent people; emergency or disaster relief services, facilities or equipment; and volunteer services.
  - d. Combat community deterioration; reduce poverty, crime, disease and environmental risks; and lessen governmental burdens through private initiatives for the purposes of the Corporation.
4. The manner in which directors of the Corporation are elected or appointed will be stated in the bylaws of the Corporation.
5. The Corporation will not have members or issue stock or shares in the Corporation.
6. The name and street address of the initial registered agent of the Corporation and the registered agent's written acceptance of appointment as a registered agent are:
  - a. Joel D. Dalrymple, 422 5<sup>th</sup> Avenue North, Jacksonville Beach, Florida 32250.

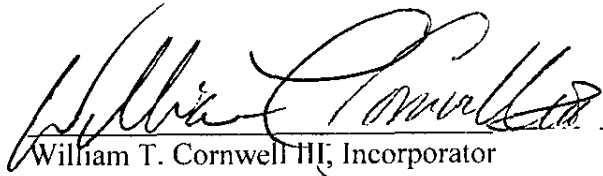

7. The name and address of the incorporator are William T. Cornwell III, 4235 Marsh Landing Boulevard, #322, Jacksonville Beach, Florida 32250

8. The net earnings of the Corporation shall not inure to the directors, officers or any private persons. However, the Corporation may pay reasonable compensation for services rendered and make payments and distributions under its purposes. The Corporation shall not, in its substantial activities, advocate or promote propaganda, attempt to influence legislation, or act in any political campaign for or against any candidate for public office. The Corporation shall not undertake activities prohibited by (a) an exempt organization under IRC section 501(c)(3) or (b) an organization that may receive deductible contributions under IRC section 170(c)(2).

9. If the Corporation is dissolved, its assets shall be distributed to an exempt organization under IRC section 501(c)(3), to the Jacksonville Beach Church of Christ or other church, or to a federal, state or local government for a public purpose, and as authorized under state law.
