The undersigned, for the purpose of forming a non-profit corporation under Chapter 617 of the Florida Statutes, hereby certify;

ARTICLE 1

NAME

The name of the corporation is the Live Oak Lions Charities, Inc.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS
