## Articles of Incorporation of Coen Foundation, Inc. A Not for Profit Organization

2008 HAR 25 P 1: 35

SECRETARY OF STATE TALLAHASSEE, FLORIDA

Article I: The name of the Corporation shall be Coen Foundation, Inc.

Article II: This Corporation is to exit perpetually.

Article III: The place in this state where the principal office of the Corporation is to be located is the City of Miami, Dade County, Florida, 10690 SW 7 Terrace, Miami, Florida, 33174.

Article IV: Said corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
